WHAT IS AN EMERGENCY RESPONSE PLAN (ERP)?

AN ERP IS A WRTTEN SET OF INSTRUCTIONS THAT OUTLINES WHAT WORKERS AND OTHERS AT THE WORKPLACE SHOULD DO IN AN EMERGENCY.

AN ERP MUST PROVIDE & INCLUDE THE FOLLOWING INFO:

- EFFECTIVE RESPONSE TO EMERGENCY
- EVACUATION PROCEDURES
- EMERGENCY SERVICES NOTIFICATION
- MEDICAL TREATMENT & ASSISTANCE
- EMERGENCY PROCEDURE TESTING & FREQUENCY
- TRAINING FOR IMPLEMENTATION OF THE ERP
- FULL RANGE OF HAZARD MANAGEMENT- FIRE, EXPLOSION, MEDICAL EMERGENCY, CHEMICAL INCIDENTS, BOMB THREATS, ARMED CONFRONTATION, NATURAL DISASTERS, CONFINED SPACES, ASBESTOS, DEMOLITION, FALL ARREST SYSETMS, ETC.
- DETAILS FOR FIRE WARDENS & KEY PERSONNEL.

HOW DOES THE PROCESS WORK?

- E FIRE & SAFETY, IN CONJUNCTION WITH YOUR SITE REPRESENTATIVE OR EMERGENCY PLANNING COMMITTEE, WILL ATTEND SITE AND CARRY OUT AN INITIAL RISK ASSESSMENT TO DETERMINE THE BEST PROCEDURES FOR YOUR SITE.
- A "DRAFT" COPY OF THE ERP IS DEVELOPED AND A FURTHER SITE MEETING WITH NECESSARY PARTIES IS HELD TO DISCUSS ALL ASPECTS OF THE ERP.
- ONCE THE ERP IS APPROVED, A BOUND PRINTED COPY AND PDF VERSION IS SUPPLIED TO THE CLIENT.
- SHOULD ADDITIONAL SITE VISITS OR CHANGES BE REQUIRED, ADDITIONAL CHARGES MAY APPLY.
